- The programs have been granted accreditation for 3 years. A.Y. Dadabhai Technical Institute, Kosamba Mahuvej Road, Near Old Mariyambai Hospital, Kosamba Surat - Gujarat 394120 should submit the Compliance Report at least six months before the expiry of validity of accreditation mentioned above so as to be eligible for consideration by the concerned Committee in NBA for further processing of the accreditation status.
- The accreditation status awarded to the programs as indicated in the above table does not imply that the accreditation has been granted to A.Y. Dadabhai Technical Institute, Kosamba Mahuvej Road, Near Old Mariyambai Hospital, Kosamba Surat - Gujarat 394120 as a whole.
